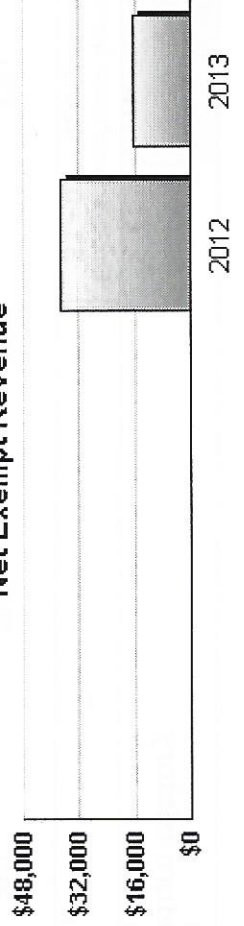
## Exempt Revenue (Loss)

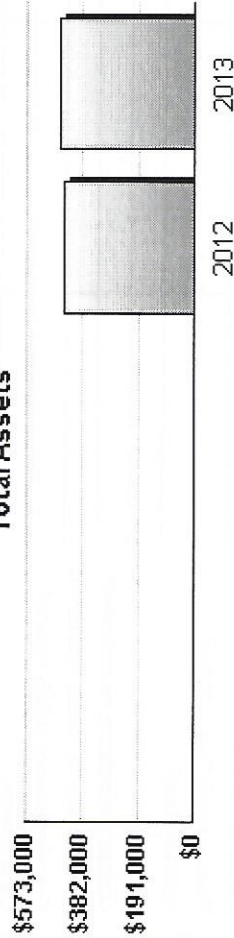

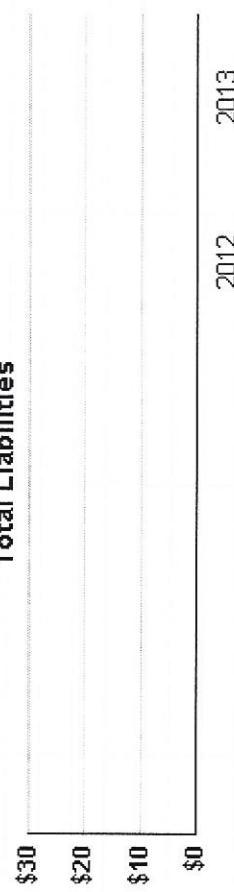

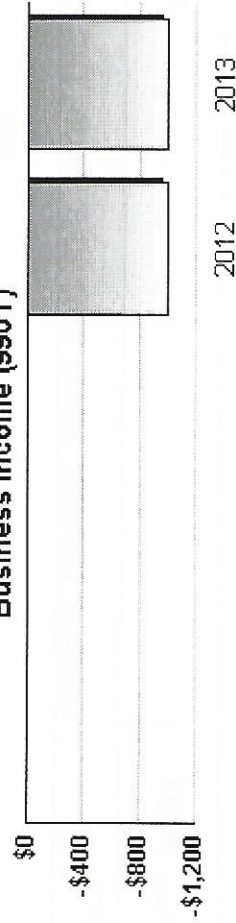
## Total Assets
